## RELEASE AND WAIVER OF LIABILITY AGREEMENT.

IN CONSIDERATION of being permitted to participate in any of the activities of Sherwood Dog Training Club, Inc. (hereinafter "SDTC"), the undersigned, for himself/herself and for all personal representatives, heirs, assigns and next of kin:

- 1. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE SDTC and/or any of its members, employees, officers, owners, agents, promoters, operators, representatives and/or other participants (hereinafter "releasees") for any loss or damage, and any claim or demands therefor, on account of injury to the person or property, or resulting in death, of the undersigned, arising out of or in any way related to SDTC activities, whether caused by the negligence of the releasees or otherwise;
- 2. HEREBY EXPRESSLY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY IN-JURY, PROPERTY DAMAGE OR DEATH arising out of or related to SDTC activities, whether caused by the negligence of the releasees or otherwise;
- 3. HEREBY ACKNOWLEDGES THAT PARTICIPATION IN SDTC ACTIVITIES MAY BE DAN-GEROUS and involves the risk of bodily injury, property damage and/or death;
- 4. HEREBY ACKNOWLEDGES THAT SDTC ACTIVITIES AS USED IN THIS AGREEMENT includes all SDTC functions and activities without restriction of any kind, including, but not limited to, dog obedience training, any classes, matches, trials, workshops, meetings, Canine Good Citizen testing, participation in the Responsible Dog Owners day; as well as setting up and taking down facilities for the foregoing activities and travel to and from such activities.
- 5. A LEGAL GUARDIAN SIGNING BELOW ON BEHALF OF A MINOR CHILD AGREES TO DEFEND, INDEMNIFY AND HOLD HARMLESS the releasees from any claim for injury or damage to such child.
- 6. I certify and represent that the dog(s) I have brought to any events is(are) not a hazard to other dogs, other animals or other people. All dogs will be under my control.

I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE BEING MADE TO ME AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
